EMPLOYEE RIGHTS

PAID SICK LEAVE AND EXPANDED FAMILY AND MEDICAL LEAVE UNDER THE FAMILIES FIRST CORONAVIRUS RESPONSE ACT

The **Families First Coronavirus Response Act (FFCRA or Act)** requires certain employers to provide their employees with paid sick leave and expanded family and medical leave for specified reasons related to COVID-19. These provisions will apply from April 1, 2020 through December 31, 2020.

▶ PAID LEAVE ENTITLEMENTS

Generally, employers covered under the Act must provide employees:

Up to two weeks (80 hours, or a part-time employee's two-week equivalent) of paid sick leave based on the higher of their regular rate of pay, or the applicable state or Federal minimum wage, paid at:

- 100% for qualifying reasons #1-3 below, up to \$511 daily and \$5,110 total;
- ⅔ for qualifying reasons #4 and 6 below, up to \$200 daily and \$2,000 total; and
- Up to 12 weeks of paid sick leave and expanded family and medical leave paid at ⅓ for qualifying reason #5 below for up to \$200 daily and \$12,000 total.

A part-time employee is eligible for leave for the number of hours that the employee is normally scheduled to work over that period.

▶ ELIGIBLE EMPLOYEES

In general, employees of private sector employers with fewer than 500 employees, and certain public sector employers, are eligible for up to two weeks of fully or partially paid sick leave for COVID-19 related reasons (see below). *Employees who have been employed for at least 30 days prior to their leave request may be eligible for up to an additional 10 weeks of partially paid expanded family and medical leave for reason #5 below.*

▶ QUALIFYING REASONS FOR LEAVE RELATED TO COVID-19

An employee is entitled to take leave related to COVID-19 if the employee is unable to work, including unable to **telework**, because the employee:

▶ ENFORCEMENT

The U.S. Department of Labor's Wage and Hour Division (WHD) has the authority to investigate and enforce compliance with the FFCRA. Employers may not discharge, discipline, or otherwise discriminate against any employee who lawfully takes paid sick leave or expanded family and medical leave under the FFCRA, files a complaint, or institutes a proceeding under or related to this Act. Employers in violation of the provisions of the FFCRA will be subject to penalties and enforcement by WHD.

*** FOR THOSE STILL REQUIRED TO WORK AWAY FROM HOME NEEDING CHILDCARE***

Greetings,

Governor Pritzker, his staff, his Office of Early Childhood Development (GOECD), and the leadership at the Illinois Departments of Human Services (IDHS) and Children and Family Services (DCFS) know that child care is always a critical work support for families. That is true even now as our state enters a "stay at home" strategy to slow the spread of COVID-19.

Per Governor Pritzker's Executive Order on Friday, March 20, 2020, all child care programs across the state were ordered to close. Where possible, children should be kept at home. However, we know that is not an option for some of our essential workers, and we are working with DCFS, DHS, and partners throughout the state to develop child care options for these families.

We have developed a COVID-19: Emergency Child Care for Communities & Providers webpage to connect you with information to understand your options for offering and accessing child care for essential workers within your community during this pandemic. Through this page you can learn how child care programs can apply to become an Emergency Child Care Center, how child care homes can operate as license-exempt homes serving six or fewer children, and how communities can ensure that parents are connected to the resources they need. If you are without access to paid sick leave or unable to work because of COVID-19, you should apply for Unemployment benefits right away. **Even if you go back to work in 2-3 weeks**. The State of Illinois has waived the one week waiting period.

ENERGY ASSISTANCE & RENTAL ASSISTANCE PROGRAMS

There are numerous energy assistance programs available to those who meet the income guidelines.

- **LIHEAP** – Low Income Heating Assistance Program is an annual assistance program that helps with the high cost of heating. Please call McHenry County Housing Authority located at 1108 Route 47, Woodstock, IL - 815.338.7752 to schedule an appointment.
- **NICOR Sharing** – Annual assistance program that helps with the high cost of heating. This program is for people that do not qualify for LIHEAP and have NICOR as their natural gas provider. Disabled Veterans may receive both LIHEAP & NICOR Sharing. Please call Dorr Township located at 1039 Lake Avenue, Woodstock, IL - 815.338.0125 to schedule an appointment.
- **Hebron Township** – Emergency Assistance that may assist with past due rent, mortgage, or utilities. Please call Hebron Township located at 10206 Seaman Road, Hebron, IL - 815.648.2994.
- **Salvation Army** – may assist with utilities, rent, or prescriptions. Please call McHenry Township located at 3703 N. Richmond Road, Johnsburg, IL - 815.385.5605 as they administer Salvation Army funds for Hebron residents.
- **Catholic Charities** – may assist with utilities, rent, or prescriptions. They are located at 5141 W. Bull Valley Road, McHenry, IL. 815.344.6956.
- **St. Vincent de Paul** – may assist with utilities, rent, or prescriptions.

If you live West of Route 47 – call St. Mary in Woodstock – 815.344.7711

If you live East of Route 47 – call St. Peter in Spring Grove – 815.675.2288

- **Hebron Community Food Pantry** – located at 10206 Seaman Road, Hebron, IL. Open 1st & 3rd Thursday of the month from 2-4. Please call 815.790.7267 or 815.648.2070.

- **SENIORS & DISABLED** – Seniors & Disabled may qualify for the Benefit Access Program which assists with a discount on your license plate sticker and a Free Ride RTA/METRA Pass. You must meet the income guidelines. If applying before April 20, 2020 – use 2018 total income. Applications after April 20, 2020 – use 2019 total income. You must apply online at <https://www2.illinois.gov/aging/BenefitsAccess>. If you need help with application, please call McHenry Senior Services at 815.344.3555 or Hebron Township at 815.648.2994 to schedule an appointment.

Over income for the Benefit Access Program? You are still eligible for a Reduced Fare RTA/METRA Pass.

Scam Alerts!!!

Targeting Tax Professionals - Increasingly, tax professionals are being targeted by identity thieves. Many of these criminals belong to sophisticated, organized syndicates that work to gather personal data to file fraudulent federal and state income tax returns. The IRS also warns tax professionals of fake payroll direct deposit and wire transfer emails.

The IRS has established a process that will allow businesses and payroll service providers to quickly report any data losses related to the W-2 scam currently making the rounds. If notified in time, the IRS can take steps to prevent employees from being victimized by identity thieves filing fraudulent returns in their names.

Some taxpayers receive emails that appear to be from the Taxpayer Advocacy Panel (TAP) about a tax refund. These emails are a phishing scam, trying to trick victims into providing personal and financial information. **Do not respond or click any link!** If you receive this scam, forward it to phishing@irs.gov and note that it seems to be a scam phishing for your information.

TAP is a volunteer board that advises the IRS on systemic issues affecting taxpayers. It never requests, and does not have access to, any taxpayer's personal and financial information.

Thousands of people have lost millions of dollars and their personal information to tax scams. Scammers use the regular mail, telephone, or email to set up individuals, businesses, payroll and tax professionals. **The IRS does not initiate contact with taxpayers by email, text messages or social media channels to request personal or financial information. The IRS Does Not Call You!!!**

What is MCRide?

MCRide Dial-a- Ride is a great way to get around McHenry County. Whether you need transportation for work, school, shopping, medical appointments or just to visit a friend, MCRide provides an affordable and flexible way to travel!

As a dial-a-ride program, MCRide service is "on-demand" and vehicles do not travel in a fixed route each day. Riders schedule their trips in advance and the vehicle provides curb-to-curb service from the rider's desired pick-up and drop-off destinations. MCRide is a shared-ride service, so vehicles may make stops for other passengers.

How Do I Reserve a Trip?

- Call **1-800-451-4599** (or use 711 for the Illinois Relay Service) to schedule a ride. Select "McHenry County" from the automated prompt and a live person will help you to schedule a ride.
- Spanish speaking call takers are available.

Reservation hours are Monday-Friday from 5:30 am to 6:00 pm and Saturday-Sunday from 8:30 am to 4:00 pm. On the weekends, because of low staff levels, call takers only make same-day reservations. Trips for Saturday, Sunday or Monday can be reserved on the preceding Friday. The Call Center is also open (to take trip reservations) on Holidays from 8:00 am to 5:00 pm.

Seniors and individuals with a disability can reserve their trips up to seven (7) days in advance. The general public (all riders) can reserve their trips 2 days in advance (starting January 1, 2020). If you are using MCRide for both legs of a trip (going and coming), remember to make both trip reservations at the same time!

When Can I Ride?

MCRide operates according to the schedule shown below. Observed Holidays include: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve, and Christmas Day.

WATER:

A water usage tip...a leaky faucet or a running toilet can lead to a high water and sewer bill. Please check for even a small leak; you may save quite a bit on your bill!

Upon completion, please email it to water@villageofhebron.org, put it in the drop box located in front of the Village Hall or return it to the Village Clerk or Water/Sewer Billing Clerk. Coming this Spring...Hydrant Flushing. Please check the Village website under "Notifications" for alerts. Signs will be posted throughout the Village as well.

SEWER:

Please **DO NOT** flush any hazardous chemicals Down the sewer! Also, pouring grease down your drains can cause your drains to plug up and lead to costly plumbing bills!

In addition, please **DO NOT** put flushable wipes or rags down the sewer as this will eventually lead to sewer backups!!!
