#### FROM THE VILLAGE CLERK



## **Dollars and Sense**

From the Treasurer's Office

The Village's fiscal year ended April 30, 2018. Both the General Fund and the Water and Sewer Fund were audited in accordance with Illinois State Law and current Governmental Accounting Standards by Roach and Associates. The Board received the completed audit at the October, 2018 meeting.

#### **General Fund Budgetary Highlights:**

The General Fund revenues exceeded the estimated revenues by \$44,306.

The General Fund expenditures were less than the estimated expenditures by \$96,464.

The General Fund is the chief operating fund of the Village. On April 30, 2018, the fund balance of the General Fund was \$541,391. This balance includes the key departments including Administration, Streets, Police and Building Department. The Proprietary Fund includes Sewer and Water. It is important to note that the General Governmental Funds and the Proprietary Fund including both Sewer and Water cannot be intermingled. They are two separate accounting entities.

This audit report reflects the new improved pay back schedule for the IEPA Loan. President Martinez successfully renegotiated the loan down to a 1% interest rate with a more favorable repayment schedule. The new schedule is on page 40 of the audit report.

No funds had expenditures that exceeded the appropriations.

#### Budget Planning for next fiscal year:


The Department Heads will be giving input regarding requested priorities for their departments and the Treasurer's Office will put this in a format to be reviewed by the President and the Finance Committee to put together a balanced budget that addresses current needs, saves money set aside for future long term projects and arrive at projections of revenue for the upcoming year. This is a tedious process, but one that does pay off in the form of accomplishing the goals and staying within a balanced budget. As mentioned above, we are really working on two separate budgets. One is for the General Fund and the other for the Water and Sewer Fund. Input for Village goals and needs, to be included in the Budget, are always welcome as we work on the budget between November and March.

You can find the complete audit as well as this year's budget on the Village website. As always we encourage you to ask any questions about the finances of the Village.

# Believe it or not, it is that time of year again...Time to think about snow removal!

Per Village Ordinance 216-17-920, Title 6B-1, Chapter 4 regarding <u>snow removal</u>, the person occupying the ground floor of any building, the owner/user of any lot without a structure theron, and the owner of any vacant building or other premises shall use reasonable efforts to remove the snow and ice accumulating on the abutting sidewalks within 24 hours after any snowfall has ceased. If snow or ice cannot be removed, the surface shall be sanded or otherwise treated to lessen the hazard for pedestrians until the climate permits removal.

**Title 6B-2, Chapter 4:** Any person violating Section 6B-1 shall be fined \$25.00 for each offense.

## Call Before You Dig!!!




Planning a home improvement project? Planting a tree? Installing a fence or deck? WAIT!

Call 811\* before you dig

When starting a project that involves digging, state law requires that anyone engaging in any type of excavation contact JULIE (Joint Utility Locating Information for Excavators) by calling 811, a state-wide, toll-free number, to have utility lines professionally marked. Calling 811 is the most important step prior to starting a digging project because it alerts excavators to the presence of underground utility lines.



## Recycling Tips from Waste Management





Did you know all your good recycling work could be going to waste when you put recyclables in plastic bags in your recycling container? Free your recyclables to ensure they have a second life. Ditch the plastic bags and empty recyclable materials directly into your recycling container. If you collect recyclables in plastic bags at home in the kitchen, office, or bathrooms, just remember to empty those bags directly into your recycling container before taking it to the curb. Plastic bags wreak havoc on processing equipment and pose safety hazards to workers. Take loose plastic bags back to local retailers to recycle or check plasticfilmrecycling.org.


## Notes from public works:

#### STREETS:

The Public Works Department has been finishing up the last of the large sidewalk repairs and will be getting ready to do some smaller repairs.

The Department would like to thank Pipeview and Matt Johnson for coming to Hebron to take pictures and video of a sewer line the Village had trouble with. Matt located the problem and we were able to fix it.

We also had the McHenry County Road District come to Hebron with their vacuum/jetter truck and we were able to clean a lot of our storm drains out. We would like to thank them and, hopefully, we can get them back to do some more cleaning!





## WATER/SEWER DEPARTMENT



Water and sewer bills are due the 1st of each month. Bills will go out after the 1st of each month. If you do not receive your water bill by the 15th of the month, please call 815-648-2353, extension 20 or email wsbilling@villageofhebron.org. Also, if you are selling your home, you will need a final read to close on your home. Please contact water and sewer billing 24 hours in advance, by phone or email. You will need to pay your final bill the day of the final read.

The current water usage rate is \$.96 per 100 cubic feet; sewer usage is \$11.79 per 100 cubic feet. The water base fee is \$17.05 per month; sewer base fee is \$11.79 per month. A late fee of 10% of the balance is added on after the due date. Just a reminder, you can pay your bill in person at the Village Hall. In addition, you can pay through the U.S. Postal Service or online using E-Pay. Please keep in mind that the Village is not responsible for late payments received in the mail. Thank you!

### WATER/SEWER DEPARTMENT continued...

The Sewer Department has made some sewer repairs. The McHenry County Department of Transportation has helped the Village jet out some troublesome storm drains. As a reminder, it is unsafe to flush or pour any hazardous chemicals into the sanitary system! Thank you for your cooperation in this regard.



### Don't let your toilet waste water!

A silent leak in your toilet can waste several thousand gallons of water each year and place unnecessary demands on your sewer system or septic tank. In addition, it will cause a higher water and sewer bill for you. Usually you cannot hear the leak because it runs slowly out of the tank. If the flow dial on your water meter is spinning when you have no water running in you home, there is a leak!

How can you discover if your toilet leaks? Follow these easy steps:

- 1. Lift the lid off of your toilet tank.
- 2. Place 3 or 4 drops of ordinary food coloring into the toilet tank (do NOT use dye, as it may stain).
- 3. Wait. Do not flush or otherwise disturb the toilet for 1 to 2 hours.
- 4. At the end of the waiting period, observe the toilet bowl. If the color that you placed in the tank now appears in the bowl, you have a leak!

Most frequently, defective flush valves that tend to wear out after several years cause toilet leaks. See your hardware store or plumber to obtain an inexpensive and easy to install
