Closed Village Board may hold a closed meeting to consider, among other items, the following under the Illinois Open Meetings Act:

1) the appointment, employment, compensation, discipline, performance, or dismissal of specific employees of the Village, including hearing testimony on a complaint lodged against an employee to determine its validity; 2) collective negotiation matters between the Village and its employees or their representatives, or deliberation concerning salary schedules for one or more classes of employees;
3) the purchase or lease of real property for the use of the Village; including meetings held for the purpose of discussing whether a particular parcel should be acquired; and 4) litigation, when an action against, affecting or on behalf of the Village has been filed an pending before a court or administrative tribunal, or when the Village finds that an actions is probable or imminent, in which cause the basis for the finding shall be recorded and entered into the minutes of the closed meeting.

## Resolution Providing for an Estimated Levy for 2015

Be it resolved by the President and Board of Trustees of the Village of Hebron, an Illinois municipal corporation (the "Village"), as follows:

- 1. That it is determined that the *estimated* amount of taxes to be levied for 2015 by the Village of Hebron, exclusive of bonds and election costs necessary to be raised by taxation for 2015 upon the taxable property within the Village, is \$178,836.00, which is not more than 105% of the prior year's extension.
- 2. The Village does not intend to exceed the prior year's extension by more than 105%. Therefore, the Village will not be required to comply with the Truth in Taxation advertisement in the newspaper nor a public hearing to be held as required pursuant to section 18-70 of the Truth in Taxation Law, 35 ILCS 200/18-55 et. seq.
