### 6B-1-1 <u>EXCAVATIONS</u> *Ord.* 39, 10-6-58

Any person seeking to excavate in the streets and alleys within the corporate limits of the Village shall make application for such excavation to the Village President or his agent on forms provided for such purpose the by Village. Such application shall set forth the purpose and location of the excavation, the size of the opening to be made and the approximate length of time the excavation will remain open. Such application shall be accompanied by statements from all public utility companies furnishing gas, electric, telephone, water, sewer and other public services that they have been informed of the proposed excavations and that arrangements have been made to protect underground structures.

Upon approval of the application by the Village President or his agent, the applicant shall enter into an agreement with the Village and make the required cash bond to guarantee prompt and satisfactory performance of the excavation and the proper backfill, barricading, protective lighting, resurfacing and removal of unused materials.

The application and a copy of the agreement shall be made a part of the public records of the Village.

#### 6B-1-2 DUMPING ASHES IN STREETS Ord. 10-14-07; and. 1978 Code

It shall be unlawful for any person to dump or strew ashes in or upon any street in the Village.

#### 6B-1-3 <u>PUBLIC RIGHT OF WAY</u> *Ord.* 399, 5-6B-85

The definitions for purposes of this Section are as follows:

Roadway right of way is defined as those areas existing or acquired by dedication or by fee simple for highway purposes; also, the areas acquired by temporary easement during the time the easement is in effect:

Project right of way is defined as those areas within the project right of way lines established jointly by the Village and the State which will be free of encroachments except as hereinafter defined.

#### 6B-1-4 <u>PENALTY</u> Ord. 399, 5-6B-85

Any person, firm or corporation violating 6B-1-3 shall be fined not less than \$25.00 nor more than \$500.00 for each offense and a separate offense shall be deemed committed for each and every day during which a violation continues or exists.

### 6B-1-4 <u>STREET NAMES</u> *Ord.* 463 1-16-89

A. Hereafter the streets in the Village of Hebron shall be named as follows:

MAIN STREET **ILLINOIS STREET** ST. ALBANS STREET **CHURCH STREET UNION STREET CENTER STREET JEAN DRIVE** PRICE ROAD McKINLEY AVENUE HARRISON AVENUE FOURTH AVENUE THIRD AVENUE PRAIRIE AVENUE MAPLE AVENUE **BIGELOW AVENUE** MEAD AVENUE FREEMAN ROAD ROUTE 173

B. Hereafter, any streets created or annexed to the Village shall be designated as follows:

North-South ways shall be STREETS East-West ways shall be AVENUES.

- C. All names of future roadways, whether annexed or newly created by the Village, shall be approved by the Village Board.
- D. The Village Engineer is hereby directed to correct the zoning map in accordance with the above change.

#### 6B-1-6 PEDESTRIAN USE OF STREETS 06-07-784

A. Where a sidewalk is provided and its use is practicable, it shall be unlawful for any pedestrian to walk along and upon an adjacent roadway.

- B. Where a sidewalk is not available, any pedestrian walking along and upon a highway shall walk only on a shoulder, as far as practicable from the edge of the roadway.
- C. Where neither a sidewalk nor a shoulder is available, any pedestrian walking along and upon a highway shall walk as near as practicable to an outside edge of a roadway, and, if on a two-way roadway, shall walk only on the left side of the roadway.
- D. Except as otherwise provided in this Code, any pedestrian upon a roadway shall yield the right-of-way to all vehicles upon the roadway.
- E. Any person violating this Section shall be fined \$25.00 for each offense.

# 6B-1-7 OPERATING OF NON-HIGHWAY VEHICLES ON VILLAGE HIGHWAYS, ROADWAYS OR STREETS PROHIBITED 23-24-1012

#### A. Definitions.

- 1. "Non-highway vehicle" means motor vehicle not specifically designed to be used on a highway, roadway or street including:
  - a. an "all-terrain vehicle", hereby defined as any motorized off-highway device designed to travel primarily off-highway, 50 inches or less in width, having a manufacturer's dry weight of 1,500 pounds or less, travelling on 3 or more non-highway tires, designed with a seat or saddle for operator use, and handlebars or steering wheel for steering control;
  - b. a "golf cart", hereby defined as a vehicle specifically designed and intended for the purposes of transporting one or more persons and their golf clubs or maintenance equipment while engaged in the playing of golf, supervising the play of golf, or maintaining the condition of the grounds on a public or private golf course;
  - c. an "off-highway motorcycle", hereby defined as any motorized device designed to travel primarily off-highway on 2 wheels, having a seat or saddle for the use of the operator, upon or by which any person, persons or property may be transported or drawn; or
  - d. a "recreational off-highway vehicle", hereby defined as any motorized off-highway device designed to travel primarily off-highway, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less for gas-powered engines or 3,000 pounds or less for electric-powered engines, traveling on 4 or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control.

- 2. "Highway" means the entire width between the boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.
- 3. "Roadway" means that portion of a highway improved, designed or ordinarily used for vehicular travel, exclusive of the berm or shoulder. In the event a highway includes two (2) or more separate roadways, the term "Roadway" as used herein shall refer to any such roadway separately but not to all such roadways collectively.
- 4. "Street" means the entire width between boundary lines of every way publicly maintained when any part thereof is open to the use of the public for purposes of vehicular travel.
- B. It is unlawful for any person to drive or operate a non-highway vehicle upon any street, highway or roadway in the Village.
- C. It shall be not unlawful for any person to drive or operate a non-highway vehicle, as defined in paragraphs (1) and (4) of subsection (A) of this Section on a Village highway, roadway or street for the purpose of conducting farming operations to and from the home, farm, farm buildings, and any adjacent or nearby farm. Such vehicle must be covered under a farm, home, or non-highway vehicle insurance policy issued with coverage amounts no less than the minimum amounts set for bodily injury or death and for destruction of property under 625 ILCS 5/7-203.
- D. <u>Penalty</u>. Unless otherwise provided, any person, firm, or corporation violating 6B-1-7 shall be fined not less than \$250.00 nor more than \$750.00 for each offense.
