6B-3-1 GENERAL REGULATIONS

No person shall roller skate or ride a skateboard within the municipal boundaries of the Village without complying with the terms of this Chapter 3. As used herein, the term "roller skate" shall mean to skate on or use as a means of transportation any type of roller skates, roller blades, street skates, skate boards or scooters.

6B-3-2 STREETS

- A. Except as provided for in Section 6B-3-2 herein, no person shall roller skate or use as a means of transportation any type of roller skates, roller blades, street skates, skateboards or scooters on any public street in a reckless manner or without exercising due care for the safety of other persons using the street. Village ordinances pertaining to pedestrians crossing streets shall apply to persons crossing a street on roller skates, roller blades, street skates, a skateboard or a scooter. No person crossing a street on roller skates, roller blades, street skates, a skateboard or a scooter shall travel at a speed or in a manner that jeopardizes the safety of other persons using the crosswalk.
- B. No person shall roller skate or use as a means of transportation any type of roller skates, roller blades, street skates, skateboards or scooters on (1) that portion of Main Street/Illinois Route 47, located between the north line of Mead Avenue and the south line of 4th Street and (2) that portion of Illinois Route 173 located between the east line of Illinois Street and the intersection of Illinois Route 173 with Price Road. This restriction is applicable to the driving surface, public parking areas and public or private sidewalks located within and adjacent to the Main Street/Illinois Route 47 right-of-way.

6B-3-3 SIDEWALKS

Except as provided for in Section 6B-3-2 herein, no person shall roller skate or use as a means of transportation any type of roller skates, roller blades, street skates, skateboards or scooters on any public sidewalk in a reckless manner or without exercising due care for the safety of other persons

using the sidewalk.

6B-3-4 <u>UNAUTHORIZED USE OF ROLLER SKATES AND SKATEBOARDS ON PRIVATE PROPERTY</u>

No person shall roller skate or use as a means of transportation any type of roller skates, roller blades, street skates, skateboards or scooters on private property without the permission of the owner or operator of the property. The police may remove or cause to be removed any person roller skating or using as a means of transportation any type of roller skates, roller blades, street skates, skateboards or scooters on private property, when requested to do so by the owner or operator of said private property.

6B-3-5 PENALTY

Any person violating any provisions of this Chapter 3 shall be fined not less than \$25.00 for each offense and shall be responsible for the Village's cost of prosecution including reasonable attorney fees. Each day that a violation occurs shall be considered a separate offense. Restitution by the violator shall also be made for any public property damaged or destroyed as a result of a violation.
