8-3-1 DEFINITIONS

Terms used in this Code shall mean as follows:

Owner: Means a person other than a lien holder having a property interest in or title to a vehicle, trailer or recreation vehicle. The term includes a person entitled to use or possession of a vehicle, trailer or recreation vehicle, subject to an interest in another person, reserved or created by agreement and securing payment or performance of an obligation.

Parking: It a stationary placement of any vehicle, trailer or recreation vehicle for a continuous period in excess of forty-eight (48) hours.

Recreational Vehicle: Is a vehicular, portable structure built on a chassis, designed to be used as a temporary dwelling for travel, recreational and vacation uses and/or vehicles with “RV” license plates. A recreation vehicle shall include, but not be limited to, the following: travel trailer, pickup, camper, motorized home, camping trailer.

Temporary Parking: Is a stationary placement of any vehicle, trailer or recreation vehicle for a continuous period of less than forty-eight (48) hours.

Vehicle: As described in Chapter 11, Article I of the Illinois Vehicle Code, as amended (Illinois Revised Statutes, Chapter 95 1/2, Sections 1-102 *et seq.* and 11-100 *et seq.*).

8-3-2 GENERAL CONDITIONS

- A. **Flammable Liquids:** The owner of a recreational vehicle shall not park, let stand, or store such a vehicle leaving flammable liquids aboard.
- B. **Dangerous or Unsafe Storage:** The owner of a vehicle, trailer or recreational vehicle shall not park, let stand, or store such vehicle in such a manner as to create a dangerous or unsafe condition on the property where parked, permitted to stand, or stored. Parking, standing or storing the vehicle, trailer or recreational vehicle in such a fashion that such vehicle may tip or roll shall be considered a dangerous and unsafe condition.
- C. **Street Parking:** At no time shall any trailer or recreational vehicle be permitted to park on any Village street or parking lot. At no time shall a trailer be left upon a Village street or parking lot unattached to a motorized vehicle.

- D. Proof of Ownership: A legal or beneficial owner of, or lessee of the property shall have, and display upon request to authorized Village officials, proof of ownership of a parked, standing or stored vehicle, trailer or recreational vehicle.
- E. Dumping: Trailers and recreational vehicles shall dump sewage only into approved sanitary facilities.

8-3-3 RESIDENTIAL REGULATIONS

- A. A vehicle, trailer or recreation vehicle which may be parked, permitted to stand or stored out of doors shall be maintained in mobile condition.
- B. No more than one (1) trailer or recreation vehicle may be stored on any one residential lot.

8-3-4 MISCELLANEOUS REGULATIONS

- A. No person shall store on any property owned or occupied by him any trailer or recreation vehicle which is not owned by him or a member of his family dwelling in said residence.
- B. Trailers and recreation vehicles may be used for sleeping purposes to accommodate persons temporarily visiting a Village resident provided said vehicle or recreation trailer is not parked on any Village street or parking lot. Other than as provided herein, no person shall use a trailer or recreation vehicle for sleeping purposes. (*Ord. 476, 7-17-89*)
