### Discussion and vote on a liquor license for Jitenderakumar Shah (Quick Stop)

President Martinez told the Board that Mr. Shah would be taking over the gas station in town and would like to ask the Village for a class B liquor License. Trustee Vole made a motion to approve a class B liquor license for Jitenderakumar Shah. Trustee Shepherd seconded the motion. Trustees Shepherd, Ritzert, Vole, Mogan and Lange approved the motion by answering aye. Motion carried.

### Discussion and vote on employee insurance options

President Martinez presented a quote to the Board on insurance options for the fulltime Village employees. She then asked the Board should the Village decide to offer said insurance what portion of the cost would the Village be willing to pay. She spoke to them about using gaming tax monies the Village receives to fund the Villages portion of the insurance. She suggested \$500 per employee. Trustee Mogan said that he would be in favor of the Village paying 80% of the employee premiums with the thought that the Village paid lower on salaries and the better benefits would encourage employees to stay
