President Jacobson called the meeting to order at 7:04p.m.

Trustees Shepherd, Ritzert, Vole, Mogan, Georgi and Canfield answered aye to roll call. Also present were President Jacobson and Attorney Smoron . There were 45 people present in the audience.

**Approve minutes of the March 16, 2016 Village Board Special meeting**

Trustee Shepherd made a motion to approve the minutes of the March 16, 2016 Village Board Special meeting. Trustee Mogan seconded the motion. Trustees Shepherd, Ritzert, Vole, Mogan, Georgi and Canfield approved the motion by answering aye. Motion carried.

**Approve minutes of the March 21, 2016 Village Board meeting**

Trustee Mogan made a motion to approve the minutes of the March 21, 2016 Village Board meeting. Trustee Vole seconded the motion. Trustees Shepherd, Ritzert, Vole, Mogan, Georgi and Canfield approved the motion by answering aye. Motion carried.

**Approve payment of March/April 2016 Accounts Payable**

Trustee Shepherd made a motion to approve the March/April 2016 accounts payable in the amount of \$29,789.69. Trustee Mogan seconded the motion. Trustees Shepherd, Vole, Mogan, Georgi and Canfield approved the motion by answering aye. Trustee Ritzert abstained. Motion carried.

**Discussion and approval of lawn mowing bid for the 2016**

There were 3 bids for the Village of Hebron mowing 2016.

1. B&B for \$260 per mowing.
2. GK Services \$340.72 per mowing
3. S&K \$295 per mowing

Trustee Ritzert wanted to know how long the contracts was for and did the Village need to mow that long. Superintendent Nelson said they ran to Oct. 31st and that it would depend on the weather. Trustee Canfield asked if there was a copy of insurance for B&B? B&B provided a copy of insurance. Steve Vole made a motion to approve the B&B bid of \$260 per mowing. Trustee Ritzert seconded the motion. Trustees Shepherd, Ritzert, Vole, Mogan, Georgi and Canfield approved the motion by answering aye. Motion carried.

**Discussion and approval of Clarke mosquito contract for 2016**

The Board asked Superintendent Nelson to see if he could get more quotes and the issue would be tabled until next meeting. Tabled

**Public comments**

President Jacobson made a statement to the public stating that everyone was aware of his legal issues and that he loved the Village but would not be discussing such issues at this time. He stated that a blog which reported his income was incorrect and that he would not be resigning at this time. A petition was presented to the Board asking for President Jacobson's resignation. It contained 232 signatures. A second petition was presented requesting a forensic audit. It had 215 signatures. It was asked if there was really 10

President Jacobson explained that the Village was working diligently on cutting expenses in order to get the things items the Village needs. It was asked were the Village purchased The Christmas lights from. Clerk Miller stated they were purchased on an online auction.

**Board comments**


